**Excerpts from the GASPP Constitution
Re: Article III Membership**

Section 5. INSTITUTIONAL MEMBERSHIP

- X Institutional Membership is available to all TRIO projects in the State of Georgia.
- X In order to be accepted as an Institutional Member, each project (or institution when it is the site of more than one TRIO program) must have paid an annual membership fee in an amount established by the GASPP Executive Board.
- X This membership does not have voice or vote but is entitled to participation in specified workshops as designated by the Executive Board.
- X Each institutional member is entitled to register no more than two representatives to attend or participate at a reduced or no cost rate in workshop activities approved by the GASPP Executive Board.

INSTITUTIONAL MEMBERSHIP

OMB Cost circular A-21, J-28 specifically notes: (c) "Costs of an institution's membership in business, technical and professional organizations are allowable." Such membership must, of course, provide benefits to the program funded under the federal grant (be reasonable and allocable). Since GASPP is a professional organization, costs of an institution's membership may be paid with federal funds.
